

**Administrative Report of Central Relief
Committee and 14 Destitute Relief
Centers for the Year 2017-18**

ADMINISTRATIVE REPORT OF CENTRAL RELIEF COMMITTEE & NIRASHRITHARA PARIHARA KENDRAS FOR THE YEAR 2017-18

Introduction:-

The Karnataka Prohibition of Beggary Act 1975, has been enacted to prohibit beggary in the State. However, any person involved in begging will be arrested and after following the procedure he will be detained in the Destitutes Relief Centers for Rehabilitation .

These Centers are being maintained by 3% Beggary cess levied on Property Tax by the all local body authorities and deposited to the Central Relief Committee Fund under section 31(3) of the act.

Administrative Setup:-

State Level: Central Relief Committee:-

The Central Relief Committee is constituted in accordance with Section 4 of the Karnataka Prohibition of Beggary Act 1975. The Committee is consisting of 3 official members and 4 non-official Members. The Government appoints one of the member as Chairman. At present sri A.Manaih, Bellary is the Chairman, Smt.Rukmini Vittal Rathod, Smt Sujatha Vasudev, Sri Maktha Mahasena Madarasaabh Sahukar, & Sri Mayagaiah are Non Official members of Central Relief Committee appointed by the Government. Principal Secretary to Government, Finance Department, Secretary to the government Social Welfare Department, and Commissioner of Social Welfare Department are Official Members of the Committee. Joint Director of the Social welfare Department will be appointed as Secretary, Central Relief Committee on deputation.

District Level : Local Relief Committees:-

14 Destitutes Relief Centers in the 14 districts are functioning in the State. The Central Relief Committee constitutes the Local Relief Committee at the districts level under the Chairmanship of Deputy Commissioner. Joint/deputy directors of Social Welfare department will be the Member

Secretary of the Committee. In Bangalore Destitutes Relief Center the Superintendent is in the cadre of Grade-1, and Grade-B Officers with designation of Superintendent will be the Head of the Destitutes Relief Center in other 13 districts. The Local Relief Committee will function with 11 official Members.

Under the Karnataka Prohibition of Beggary Rules, 1975. Delegation of financial powers are vested to the Local Relief Committee.

Destitutes Relief Centres :-

14 Destitutes Relief Centers in Bangalore, Bellary, Belgaum, Chitradurga, Davanagere, Hubli-Dharwad, Kolar, Kalburgi, Mysore, South Canara, Raichur, Shimoga, Tumkur, & Vijayapura districts of the State are functioning.

Deputy Commissioner of Bidar District has sanctioned 7 acres 10 guntas of land in s.no 15 of Godampalli village of Bidar Taluk for Destitute Relief Center.

Staff Position:-

Relief Centers are maintained by obtaining services of Outsource Employees against Vacant Posts.

Facilities at Destitutes Relief Centres :-

- Every day Inmate are being served breakfast with coffee/tea and 2 nutritious meals (supplied by "Akshya pathra" under taken by ISkON at Bangalore centre only). In addition, banana and eggs are being provided three days per week respectively.
- Three pairs of uniform, one set of bedding, soap, oil, tooth powder, etc., are being provided to inmates. Sports activities, Yogasana, Walking activities are conducted for the inmates in all Centers.
- Medical facilities is being provided in all centres. The inmates will be admitted to the nearest Government Hospital for higher treatment.
- In Bangalore Destitutes Relief Centre one Primary Health Centre of Health Department is working with three Medical Officers and five staff nurses. Accordingly 24 hours health care of the Inmates are being taken care off. As far as mentally retarded cases are concerned a team of Doctors From Nimhans visits the centre once in 15 days to for medical checkup of the inmates .
- Vocational training are being imparted to the inmates in horticulture, coir mat making, file wrapper making, scented phenol, floor cleaner, soap oil, toilet cleaner, bleaching powder, hand wash, detergent powder, candle making etc to motivate self reliance and as a part of rehabilitation of the destitute.
- Literacy activities are being imparted to the Inmates Apart from these entertainment programmes for inmates is being arranged at open air theatres. T.Vs are provided in all centers for entertainment of the inmates.
- Infrastructure facilieties like, additional dormitories, Mini Health Clinic, Kitchen and Dining halls, Internal Roads, Barber Shop, Compound Walls, Action being taken processed to improve the system of water supply, underground drainages etc., works are undertaken in the centers in order to accommodate more number of beggars and to provide better facilities.
