

**ANNUAL REPORT OF CENTRAL RELIEF COMMITTEE AND
NIRASHRITHARA PARIHARA KENDRAS FOR THE YEAR
2022-23**

Introduction:-

For eradication of Beggary in the State The Maharaja of Mysore province His Highness Sri Jayachamarajendra Odeyar Bahaddur has formed a Committee of Higher Officers in the year 1944 for study of Beggary in the State. On the basis of report of the committee decided to start Beggars Relief Center in Bengaluru for which acquired land in Srigandhada Kavalu and Sajjepalya villages of Yeshwanthpur Hobli mainly in Bangalore- Magadi main road. In the beginning the Beggars Relief Center was started in a rented building in Bangalore. On 1st July 1948 with all basic infrastructure the Bangalore Relief Centre was inaugurated by the Maharaja of Mysore Province Sri Jayachamarajendra Odeyar Bahaddur.

The Karnataka Prohibition of Beggary Act 1975 Reg:-

The Karnataka Prohibition of Beggary Act 1975, has been enacted to prohibit beggary in the State. However, any person involved in begging will be arrested and after following the procedure he will be detained in the Beggars Relief Centers for Rehabilitation . The Act and connected Rules 1975 came into force from 19.06.1975 and 01.04.1976 respectively. As per the Act Beggary is prohibited in the State.

Relief centers are maintained by 3% Beggary cess levied on Property Tax on land and building by the local body authorities and remitted to the Central Relief Committee Fund under section 31(1) of the said Karnataka Prohibition of Beggary Act 1975.

Administrative Setup:-

State Level: Central Relief Committee:-

Central Relief Committee in the State level is constituted in accordance with Section 4 of the Karnataka Prohibition of Beggary Act 1975 for the Supervision, Direction and Control of all matters relating to the administration of Relief Centers. The Committee consisting of 3 official members and 4 non-official Members nominated by the Government. The Government appoints one of the members as Chairman. As per the Government order dated:27-07-2022 Sri M. Basavaraj Naik, Davanagere has been appointed as Chairman and Sri. K.S Devaraj, Shimoga as member of the Committee. The official members are Principal Secretary to the Government, Social Welfare Department, and Additional Chief Secretary to the Government, Finance Department, Commissioner, Social Welfare Department and Additional Director of Social Welfare Department Smt. Y.B Archana is working as Secretary, Central Relief Committee.

District Level : Local Relief Committees:-

Local Relief Centres are functioning in Bengaluru, Bellary, Belagavi, Chitradurga, Raichur, Kalburgi, Vijayapura, Davanagere, Dharwad, Shivamogga, Mangalore, Tumkur, Mysore, Kolar districts in the State. The Bangalore Relief Centre is under the administrative control of Central Relief Committee. The Central Relief Committee constitutes the Local Relief Committee at the districts level for administration of the relief centers in the local area. The Local Relief Committee consists of the Deputy Commissioner as Chairman, 11 official members and Joint/Deputy Director of Social Welfare department of the concerned districts as Member Secretary. Group-A Officer Junior Scale Superintendent Grade-1, for the Bangalore Relief Centre and Group-B cadre Officers as

Superintendents for the remaining 13 local relief centers are sanctioned for the existing vacancy post staffs are working on deputation. They are looking after day to day activities of relief centers as per the Act.

Administration of the Central Relief Committee and Local Relief Committee are carried out as per the delegation of Financial and Administrative powers vested in Central Relief and local Relief Committee under the Karnataka Prohibition of Beggary Act 1975, Rules 1975 and orders issued by the Government.

Local Relief Centres :-

There are 14 Local Relief Centers functioning in the 14 districts of the state.

The facilities provided to Beggars at Relief Centres:

1. FOOD :

Inmates at the relief centres are being provided breakfast, lunch and dinner every day. Akshaya Patra Foundation is providing breakfast and meals at Rs.69/- per day to each inmates at the Bangalore Beggars Relief Centre. Eggs and bananas are given on alternate days.

2. Clothing and Beddings :

Every Beggar will be provided one set of Beddings and 3 sets of Uniforms for one year.

All the inmates except the sick shall bath once every day. Male inmates will be given shave, Toothpaste/powder, Toilet soap, Washing Soap. In addition to this Shampoo, Coconut oil, Sanitary napkins are provided to female inmates to maintain the cleanliness. Dormitories are cleaning every day with Bleaching Powder, Phenyl, etc., to maintain the Hygienic condition. Heavy Duty washing machine for washing clothes and Solar Water Heaters for hot water are installed in all the centres and necessary action is being taken to install washing machines at other centres.

3. Medical Facility :-

There are 02 doctors and 06 nurses working in the primary health unit at the Bengaluru Beggars Relief Centre and once the beggars are arrested and brought to the centre, a preliminary health check-up will be done and treated. If further medical treatment is required, they will be referred to the concerned government hospitals for higher treatment. The mentally ill inmates are being treated under the district mental health programme by conducting medical check-ups. Special medicines are being procured and given on the advice of doctors.

Medical treatment will also be provided by government hospitals on priority at the remaining Nirashrithara Parihara Kendra's. 03 nursing staff have been recruited for each centre to supervise them and steps are being taken to improve their physical/mental health.

4. Entertainment:-

TVs have been installed in the dormitories for the entertainment of the inmates at the Nirashrithara Parihara Kendra's.. Apart from this, on special days, various organizations are allowed to conduct entertainment programmes such as drama, singing, etc. Various cultural activities and programmes are conducted by various organisations and songs, plays, yogasanas, etc. are conducted by the inmates themselves at the Rangamandira in the premises of the Bengaluru Relief Centre. Morning walks, yoga/meditation, and recreation programmes being engaged in every Nirashrithara Parihara Kendra's

5. Skill Development (Training Programmes) :-

Vocational training are being imparted to the able bodied inmates in Agriculture, Horticulture, Animal Husbandry, Sheep/Goat farming, Coir mat making, Tailoring, File wrapper making, phenyl etc., household articles making etc., to motivate and for self reliance as a part of rehabilitation of the inmates. During the training period inmates are provided with wages of Rs.75/- for 08 hours and Rs.38/- for less than 08 hours per day.

Public Awareness Programmes :-

- Beggary is prohibited in the state under the Karnataka Prohibition of Beggary Act 1975. Public awareness is conducted by distributing Handbills, Brochures, advertising in news papers, Bus branding, Audio advertisement at Bus Station and Audio-video Telecast in train T.V channel etc.,
- Toll Free Help Line no 10581 and Social Welfare Department Kalyana Mitra No.9482300400 is provided for receiving complaints regarding beggars nuisance in public places.

Sources of Revenue for the maintenance of Beggars Relief Centres:-

Section 31 of the KPB Act 1975 empowers to collect 3% beggary cess. The beggary cess will be levied on Property Tax collected on the lands and buildings. The relief centres are maintained by the beggary cess, collected and remitted by the Bruhat Bangalore Mahanagara Palike, Mahanagara Palike's, ULB's and Grama Panchayaths to the Central Relief Committee.



For the implementation of Action Plan of Central Government to make Bengaluru a beggar free city Rs.2.00 crore has been released during the year 2021-22. (A Pilot Project)

A sum of Rs.2.00 crore has been released for the year 2021-22 with a provision of Rs.4.00 crore as 100% grant (Central Government Scheme) for integrated Programme for Rehabilitation of Beggars by the Central Government. A total of Rs.80.34 lakhs has been spent on the survey and identification of beggars, protection/detention, Food, uniform bedding-clothing, professional training, daily wages, shelter home/dormitory, essential work and raw material for training etc., for the period 2021-22 and 2022-23 for Vertical-1 to 4 (up to 31-01-2023) this project is under progress.
